1. ***Itahari Sub Metropolitan City, Itahari, Sunsari*** invites sealed bids or electronic bids from Nepalese eligible bidders for the construction of “***Construction of Bituminous Asphalt Concrete Road from the Health Post to Ward No. 13 and from the Hulaki Highway in Ekata Tole to the House of Uday Katuwal, Itahari-12, Sunsari***” under National Competitive Bidding procedures. The estimated amount for the works is ***NRs. 3,094,656.25 [without VAT and contingency but including PS]***.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of ***Itahari Sub Metropolitan City, Itahari, Sunsari*** or may visit PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
3. Bidder who chooses to submit their bid may download the bidding documents for e-submission from PPMO’s Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost ***NRs. 3,000.00*** of bidding document as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at ***Itahari Sub Metropolitan City, Office of Municipal Executive, Itahari, Sunsari*** at ***2083/04/01 BS, 13:00 hours***
5. Electronic bids must be submitted to the office ***Itahari Sub Metropolitan City, Itahari, Sunsari*** by through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np) or before ***12:00 hours*** on ***2083/04/12 BS***. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at ***2083/04/12 BS, 13:00 hours*** at the office of ***Itahari Sub Metropolitan City, Office of Municipal Executive, Itahari, Sunsari***. Bids must be valid for a period of ***90 days*** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of ***NRs. 80,000.00***, which shall be valid for ***30 days*** beyond the validity period of the bid (***i.e., 120 days from the bid submission deadline***)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
