1. The Government of Nepal has applied for financing from the Asian Development Bank (ADB) toward the cost of Integrated Water Supply and Sewerage Management (Sector) Project. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The Itahari Sub-Metropolitan City, Integrated Water Supply and Sewerage Management Project, Project Implementation Unit (PIU) (the "Employer"), invites electronic bids from eligible bidders for the construction of **Itahari Water Supply System** (the "Works").
3. Major works under the contract package will be developing infrastructures for water supply in ward no. 10,11,12,13,14,15,16,17,18,19, and 20 of Itahari Sub-Metropolitan City serving about 85,000 population (2045). The main infrastructures under the Contract are 11 Deep Tube Wells with Aeration Tower / Multigrade Pressure Filter/Chlorination Units, 3 Overhead Tanks of capacities (450, 900, and 900 Cum), Transmission Pipeline length of about 2.8 Km and Distribution Pipeline length of about 550 Km with 16,970 households. Other components under the contract package are SCADA, Valve Chambers, various Valves and Fire Hydrants.
4. Open competitive bidding – international advertisement will be conducted in accordance with ADB’s Single-Stage: Two-Envelope bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
5. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding.

8. A Site Visit and Pre-Bid meeting will be held on **20 January 2026 at 10:00 Hrs NST & 14:00 Hrs NST** respectively at **Itahari Sub-Metropolitan City, Integrated Water Supply and Sewerage Management Project, Project Implementation Unit (PIU), Itahari, Sunsari**.

Interested Bidders shall submit electronic bids through PPMO’s e-GP System (<https://bolpatra.gov.np/egp>), in accordance with Instruction to Bidders, on or before **11 February 2026, 12:00 Hrs Nepal Standard Time** together with a Bid Security as described in the Bidding Document. Paper submission of Bid is not permitted. In case the day of final Bid submission falls on a public holiday, the final Bid submission date shall be following working day.
10. Technical Bids will be opened promptly after the deadline for bid submission in the presence of Bidders’ representatives who choose to attend.
11. This Invitation for Bids has been published as agreed between the Government of Nepal and Asian Development Bank and it may be cancelled at any time in case the Financing Agreement is not signed or does not achieve the effectiveness of the agreement.
