security amounting to a minimum of 55000, which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[2550100002268001] at [Rastriy Pre-Bid Meeting Shall not be held.

- 6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day. In such case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
