7. Quotation will be opened in the presence of Bidders representatives who choose to attend at 14:00 hrs on 27th Jan 2022 (13-10-2078) at Itahari Sub-metropolitan city, Office of the municipal executive, Itahari, Sunsari.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day. In such case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
9. Requirement of medicines are as specified in BOQ (WHO GMP Certified and Expiry Date Should be 18 months or 75% drug Life and as per standard specified by MoHP/DoHS).
